Non-Governmental Organization "European-Ukrainian Council for Cooperation and Development" was established on April 11, 2023.

The EUSR is a non-profit organization established on the foundation of partnership, employing a holistic approach to the recovery and development of Ukraine, particularly in the Eastern and Southern regions. The organization plays a pivotal role in state policy concerning strategic recovery and development, European integration processes, investment attraction in the regions, and international cooperation.

The EUSR comprises a collective of like-minded individuals who have joined forces to advance Ukraine's development as a member of the European family. Amid the full-scale Russian invasion of Ukraine and its attainment of candidate member status in the EU, Ukraine has garnered unprecedented political backing from the European Union and its member states. The EUCCD seeks to translate this political support into tangible cooperation.


The establishment of the organization was founded on the necessity to support initiatives that address the collective interests of Ukrainian citizens, irrespective of their location, by fostering local and regional development, as well as enhancing intra-regional, interregional, and international cooperation.





The objective of our initiative is to establish and subsequently support sustainable partnerships between interested Ukrainian and European organizations, focused on project development to secure international funding. The Council for Cooperation and Development (CCD) is an international network of organizations, with structural units (offices) also situated in the Czech Republic, Austria, and Slovakia.

Measures are currently being implemented to foster collaboration with the governments of Germany, Poland, Hungary, and Romania, which includes the obligatory establishment of offices for the Council for Cooperation and Development in these nations.







The primary objective of the Organization is to foster collaboration and enhance relations between Ukrainian and European organizations, enterprises, governmental bodies, and local self-governance institutions.

### The primary domains of the Organization's activities are:

- Support and enhancement of EU values in Ukraine;
- facilitating the preparation and advancement of initiatives designed to integrate Ukraine as a full member of the EU;
- the engagement of civil society in Ukraine's integration processes with the EU;
- support for business collaboration between economic entities of Ukraine and EU nations;
- development of the institutional capacity of Ukrainian entities at both the central and regional levels during Ukraine's European integration process;
- Development and transmission of Ukrainian values as an integral component of the broader **European society**;
- enhancing the institutional, transport, and humanitarian ties between Ukraine and the European Union, as well as its member states;
- offering assistance in the preparation for the execution of projects aimed at the European integration of Ukraine, engaging with the European Commission, the European Parliament, and the national governments of EU member states and candidates;
- promoting the advancement and adaptation of EU initiatives focused on the integration of Ukraine;
- development of collaboration among entities involved in cross-border programs between Ukraine and the EU;
- advancing the sustainable development of Ukraine within the framework of EU values.


